- 2. Each vendor must register and be approved prior to the event. A signed Guidelines and Release and Waiver of Liability Form <u>must be signed and approved</u> prior to the event.
- 3. Booth spaces will be 10ft x 10ft. A \$25.00 will be charged for booth space.
- 4. Booth set-up time begins at 9:00 a.m.
- 5. Tents, tables, chairs, and other equipment are not included in the booth space. Booths do not have power, so generators can be brought if needed.
- 6. All tents must be weighted and all equipment in good working condition. If an item could potentially cause a safety hazard, the vendor may be asked to disassemble and remove it.
- 7. Vendors are responsible for their property's cleanliness, safety, and security.
- 8. Vendors are responsible for removing all trash, displays, and equipment erected or placed on the premises at the end of the event.
- 9. A person must be present in the booth at all times.
- 10. Absolutely no alcoholic beverages are permitted for sale or consumption in your booth or on the premises.
- 11. No smoking, vaping, or any illegal activities are strictly prohibited on the premises.
